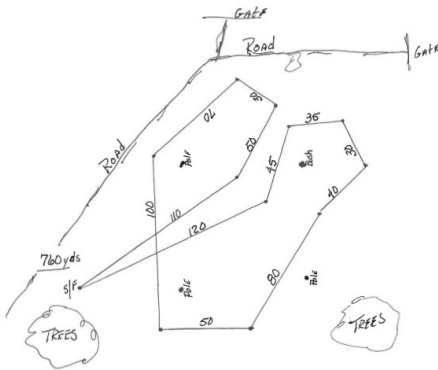

**ROLL CALL:** Begins at 1:00 pm.

Incomplete, unsigned, conditional or unpaid entries will not be accepted. **No email or fax entries accepted.** Entries will not be acknowledged by mail; they may be acknowledged by email.

**ELIGIBLE BREED AND REGISTRY:** Only purebred Ibizan Hounds may be entered in the regular stakes. All Entries in the regular stakes shall be individually registered with the American Kennel Club (ILP and PAL included), the Federation Cynologique Internationale, an ASFA recognized foreign registry or an ASFA board approved registry.

### REGULAR STAKES:

**OPEN STAKE:** Open to all eligible Ibizan Hounds, excluding ASFA Field Champions of record. First time entrants must have met the certification requirements and include a certification form and copy of registration.

**FIELD CHAMPION STAKE:** Open to Ibizan Hounds that are ASFA Field Champions

**VETERAN STAKE:** Open to Ibizan Hounds whose age is at least seven years old and have met the certification requirements.

**SINGLE STAKE:** Any eligible Ibizan Hound including those disqualified to run in other stakes. Not eligible for Best of Breed. Hounds are eligible to earn TCP and CPX titles from the Singles stake.

### NON-REGULAR STAKES\*\*\*

**BREEDER STAKE:** For two Ibizan Hounds, designated at time of entry, bred by the same individual. Singles Stake is ineligible for this non-regular stake.

**KENNEL STAKE:** For two Ibizan Hounds, designated at time of entry, owned and kenneled by the same individual. Singles Stake is ineligible for this non-regular stake.

**BENCH CHAMPION STAKE:** For any hound eligible to enter a regular stake, that is an AKC and/or CKC champion, and/or UKC Grand Champion. A copy of the hound's championship certificate must accompany each Stake entry.

**PERFORMANCE TITLED:** For any hound eligible to enter a regular stake (excluding Singles), that is an AKC, CKC or UKC performance/companion title holder of record (excluding Field Trial Titles). A copy of the hound's title certificate must accompany each entry.

**GENERATION STAKE:** An Entry Shall Consist of a stud dog, OR a brood bitch and one dog produces by that dog. Both must be entered in one of the regular stakes (Open, Field Cjchampion, Veteran but need not be owned or bred by the same person. Each Stud dog or Brood bitch can be paired with one chosen offspring; However, an offspring can be paired with either one or both parents.

*\*\*\* If a tie exists after the final runs then the dog(s) with the highest FINAL score will be declared the winner. IF the final score is tied then the dog(s) with the highest Preliminary score will be declared the winner.*

## GENERAL INFORMATION

1. All entries must be one year of age or older on the day of the trial.
  2. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
  3. Bitches in season, lame hounds and hounds will be excused at roll call, Hounds with breed disqualifications will also be excused, unless entered in Singles Stake.
  4. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake.
  5. Hounds not present at the time of roll call will be scratched.
  6. Hound certification runs will not be offered.
  7. Battery powered continuous loop machines will be used. Lures will consist of white plastic bags. Backup equipment will be available.
  8. The course will be reversed for the finals and again for the BOB run-offs. Course subject to change based upon condition of the field and weather.
  9. The Field Committee reserves the right to alter the course diagram as required by weather and/or field conditions on the day of the trial.
- 10. Please bring your own shade and water.**
11. No one, except Field Committee members, will be allowed on the field without the expressed permission of the Field Chairman.
  12. Anyone exhibiting unsportsmanlike conduct will be excused from the field for the day.

 Perpetual Trophy  
 In honor of  
 FC Kirah's I like Treybeau Best SC MC LCM5  
 2012 Hall of Fame Inductee



Dino was never a brilliant courser, never won big trials or trophies, never gained double digit titles, he just ran for the joy of coursing, only stopping when age told him to. He is the son of HOF Treybeau's KC and his birth was attended by ASFA dignitaries past and present. Pete and Camille Mendicino, Dean Wright (PopPop), Lori Coulson, and Dino's future Mommie Audrey Silverstein welcomed him into the world on March 22, 1994.

Dino started his career in April 1995 at Coastal Courser's Easter trial. "The Wall" was Region 8's toughest course; he took it like a pro and was BOB both days. That year he became an ASFA FCh and in Dec. 1996 he finished his first LCM, usually 4 or 8 points at a time. Dino's career spanned over 10 years which brought him 5 LCMs, again mostly 4 or 8 points at a time and thanks to BIF firsts. Dino was in the Ibizan top 20 for 7 years. He ran in 313 trials and retired Dec. 31, 2005.

Dino's greatest coursing fame came at "Ribbons." Almost every courser in Region 8 and beyond was related to Dino by either blood, association with his housemates, his sire and dam and their parents, friend's dogs, dogs he certified, and the people that owned his relatives. Coursing was truly a family affair during his career and brought many Region 8 competitors together at ribbons just to hear their dog's relationship to Dino. Ribbons at Hanover have not been the same since he retired. He was the greatest ambassador coursing ever had, Dino's ability to certify multiple breeds of dogs single-handedly did more to bring new people into coursing than any dog or person before or since. One ASFA judge's comment was, "If Dino had not been available to certify our first dog we would never have come back to coursing." At home Dino was the best puppy nanny and helped raise several generations and breeds of great running coursers. The last litter he helped raise was in 2007. Dino passed away in Nov. of 2009.

- ♥ Make sure to pay attention to the running order, your dog's colors, and to the paddock master – if your hound is ready and waiting, when it's his turn to run, the trial goes smoother for everyone. Any hound that is more than five minutes late in getting to the line for their course may be excused from competition for the day.
- ♥ If you are new to the sport, grab someone and ask questions! We're always happy to help "newbies" learn the ropes!
- ♥ Anybody exhibiting unsportsmanlike behavior will be excused from the field and may be subject to further disciplinary action.
