### IN ADDITION, THE FOLLOWING PERPETUAL TROPHIES WILL BE OFFERED:

- The Gillette Memorial Trophy will be awarded to the Gillette Stake Winner on Saturday.
- The AWC Perpetual Trophy is awarded to the Whippet representing the breed in the Gillette Stake.
- The Darkling Perpetual Trophy is awarded to the Borzoi representing the breed in the Gillette Stake.
- The Eterna Perpetual Trophy is awarded to the Ibizan Hound representing the breed in the Gillette Stake.
- The Nitro Perpetual Trophy is awarded to the Rhodesian Ridgeback representing the breed in the Gillette Stake.
- The Gallant Perpetual Trophy is awarded to the NGA Greyhound with the greatest cumulative score for both days at the II.
- The President's Cup, donated by Arnold Ross and \$100, donated by the current ASFA President, will be awarded to the winner of Best in International Invitational on Sunday.

**PRIZES:** Iowa Coursing Association will provide prizes for Breed winners, Best in Variety, High Scoring Single, Special Stakes winners, and placements.

**WELCOME BAGS:** Available for all Invitational entrants! Please pick one up on Saturday.

## Eligibility

### ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cimeco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Silken Windhounds, and Whippets. Provisional breeds may be entered in the Provisional Stake or the Singles Stake. Provisional breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno, Medio, & Grande), and must be individually registered with the appropriate registry.

Lure Chasing Instinct (LCI) is open to all non-sighthound breeds and sighthound mixes. LCI entrants should be registered with AKC, UKC, or ASFA.

All entries shall be individually registered with the AKC (including ILP/PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry or possess a CRN from the SPDBS.

### INTERNATIONAL INVITATIONAL ELIGIBILITY REQUIREMENTS

**Hounds:** To be eligible to enter, a hound must have earned at least 20 lifetime ASFA points or equivalent in its country of residence or is an AKC or equivalent foreign Field Champion of Record in another lure coursing field trial sanctioning organization or has placed in a Regional Invitational (with competition) PRIOR TO THE CLOSE OF ENTRIES (9/23/2024). Entrants in breed stakes must have earned the 20 lifetime ASFA points running against competition in their specific breed's stake. Points earned in singles stakes do not count towards eligibility to compete in the breed stakes. Proof of non-ASFA title and non-ASFA points for hounds should be in the form of a photocopy of the certificate, or page of formal printing, and be included with the entry.

**Singles/LCI:** Entrants must have earned 20 lifetime ASFA points.

**Provisional Stake:** Entries must have one 1st placement or two 2nd placements with competition in the Provisional Stake. Proof of non-ASFA title and non-ASFA points for hounds should be in the form of a photocopy of the certificate, or page of formal printing, and be included with the entry.

  - a. If you choose this option, please reach out to the FTS to coordinate. FTS will be showing/trialing in Iowa, central Minnesota, and Missouri (Purina Farms) prior to close of entry.
3. Do your FTS a favor and enter/pay online!
  - a. **It's your responsibility to provide accurate, legible entries. The FTS reserves the right to refuse incomplete and/or illegible entry forms.**

### **REFUNDS**

**100% of entry fees will be refunded if a written request is received by the trial secretary on or before the trial closing date – 9/23/2024.** After the trial closes, a refund will be given for ill or injured dog or handler, bereavement, and/or family emergency if the trial secretary is notified prior to the close of roll call for the trial. Bitches in season will be fully refunded if the Trial Secretary is notified prior to the close of roll call for the trial. **No refunds will be given if a request is presented after the close of roll call for the trial.** Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. **No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.** **No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.**

**CONFIRMATION OF ENTRIES:** The FTS will confirm entries as they are received via email. If you have any questions, please send an email to receive the quickest response – [iowacoursing@gmail.com](mailto:iowacoursing@gmail.com). Please – no phone calls regarding entry status.

**SUBSTITUTION OF LAME/IN SEASON HOUNDS:** The last day to substitute lame/in season hounds is Monday, 9/30. No substitutions can be made the day of the trial.

**STAKE CHANGES:** Please notify the FTS of any change of stake for your hound before the trial; preferably, by Monday, 9/30.

### **Stakes**

**OPEN:** Any eligible sighthound excluding ASFA Field Champions of Record that has met certification and II eligibility requirements.

**FIELD CHAMPION:** Any ASFA Field Champion.

**VETERAN:** Any eligible hound that has met the certification and II eligibility requirements whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years and Afghans,

Ibizan Hounds, Rhodesian Ridgebacks, Salukis, and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.

**PROVISIONAL STAKE:** Any eligible sighthound of a Provisional breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

**SINGLES STAKE:** Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Provisional breeds are not eligible for these titles.

**SPECIAL STAKES:** Breeder, Bench, Generation, and Kennel Stakes will be offered on Saturday and Sunday. LCI and Singles entry are not eligible for Special Stakes.

**Kennel Stake:** For hounds of any individual breeds; an entry shall consist of two hounds, designated at time of entry, owned and living with the same person. Hounds must be entered in one of the regular stakes (Open, Field Champion, Veteran). Scores of these two hounds will be added and the highest combined score will be awarded the Kennel Stake Award.

**Breeder Stake:** For any individual breed which shall have, designated at time of entry, two hounds bred by the same individual. Hounds must be entered in one of the regular stakes (Open, Field Champion, Veteran). Scores of these two hounds will be added and the highest combined score will be awarded the Breeder Stake Award.

*\*Kennel and Breeder Stake entries may consist of the identical pairing of dogs, but each dog may only be entered once in each stake.*

**Bench Champion Stake:** For hounds of any individual breed, eligible to enter a regular stake; that is an AKC, CKC, or ASFA-approved international show champion of record. A copy of the hound's championship certificate must accompany each Stake entry. ASFA does not recognize the UKC show champion as of Jan 1, 2022.

**Generation Stake:** For any individual breed which shall have, designated at the time of entry, two hounds consisting of a stud dog OR brood bitch and one offspring. Both must be entered in one of the regular stakes (Open, Field Champion, Veteran) but need not be owned or bred by the same person. Each stud dog or brood bitch can only be paired with one chosen offspring; however, an offspring can be paired with either one or both parents. Scores of the two hounds will be added and the highest combined score will be awarded the Generation Stake Award.

**GILLETTE STAKE:** Saturday Only. The stake will be run following the same procedures as Best in Field. The eligible hound in each breed that receives the highest qualifying combined score during competition in the Field Champion or Veteran Stake on Saturday will be randomly drawn to run in the Gillette Stake. \*Please refer to the eligibility guidelines on the Gillette Stake Entry Form.

**BEST IN INTERNATIONAL INVITATIONAL:** Sunday Only. Best in II will be run following the same procedures as Best in Field, except that all Best of Breed winners from Saturday and Sunday are eligible to compete provided they have been entered and received qualifying scores, running prelims and finals, both Saturday and Sunday. The hound that wins Best in International Invitational will be credited with winning a Best in Field.

**LURE CHASING INSTINCT (LCI) STAKE:** Open to NON sighthounds and sighthound mixes. All entries shall be individually registered with the AKC (including ILP & PAL) UKC, or ASFA.

**Small Open:** for dogs 17-1/2 inches or less at the withers and / or brachycephalic ("flat-faced") dogs who have not achieved the title of LCC.

**Small Excellent:** for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs who have achieved the title of LCC.

**Small Veteran:** for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs over the age of 7 years.

**Large Open:** for dogs over 17-1/2 inches at the withers who have not achieved the title of LCC.

**Large Excellent:** is for dogs over 17-1/2 inches at the withers who have achieved the title of LCC.

**Large Veteran:** for dogs over 17-1/2 inches at the withers who are over the age of 7 years.

**Sighthound Mix Open:** for dogs with a sighthound breed in its background who have not achieved the title of LCC.

**Sighthound Mix Excellent:** for dogs with sighthound breed in its background who have achieved the title of LCC.

**Sighthound Mix Veteran:** for dogs with sighthound breed in its background over the age of 7 years.

When running as a stake within a regular ASFA trial, Small will run 50% of the ASFA course as laid out for the sighthounds up to a maximum of 400 yards. All other stakes will run the full ASFA laid out course length.

### Running Procedures/Notice to Exhibitors

- All hounds will run twice, in trios if possible or braces (except in the Single and LCI stakes), unless excused, dismissed, or disqualified.
- Stakes will be split into flights by public random draw at 5:30PM, Friday, 10/4 if the entry in any regular stake is 20 or more.
- Bitches in season, lame hounds, and hounds with breed disqualifications will be excused at roll call.
- Hounds not present at the time of roll call will be scratched after a 5 minute grace period.
- Spayed, neutered, monorchid, or cryptorchid hounds without breed disqualifications may be entered.
- Muzzles are not required.
- Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
- A penalty of \$5 will be assessed for any loose hound not competing in the course in progress.
- The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to compete safely.
- It is expressly understood that exhibitors alone are responsible for their behavior and that of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the field trial committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made. ICA, ASFA and its agents will assume no responsibility for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. ICA and ASFA reserve the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against ICA or the ASFA or any official thereof.
- **ANYONE EXHIBITING UNSPORTSMANLIKE CONDUCT WILL BE EXCUSED FROM THE FIELD FOR THE DAY.**
- **THE FIELD COMMITTEE RESERVES THE RIGHT TO BAR KNOWN AGGRESSIVE HOUNDS FROM THE FIELD**
- **NO ONE, EXCEPT FIELD COMMITTEE MEMBERS, WILL BE ALLOWED ON THE FIELD WITHOUT EXPRESS PERMISSION OF THE FIELD TRIAL CHAIRMAN.**

### Equipment

- The lure machine is a battery powered, continuous loop system. Back-up equipment will be available.
- Lure consists of white plastic strips. If field conditions require (snow), ICA reserves the right to use black strips instead of white.

- ICA reserves the right to alter the course plan as required by weather and/or field conditions on the day of the trial.

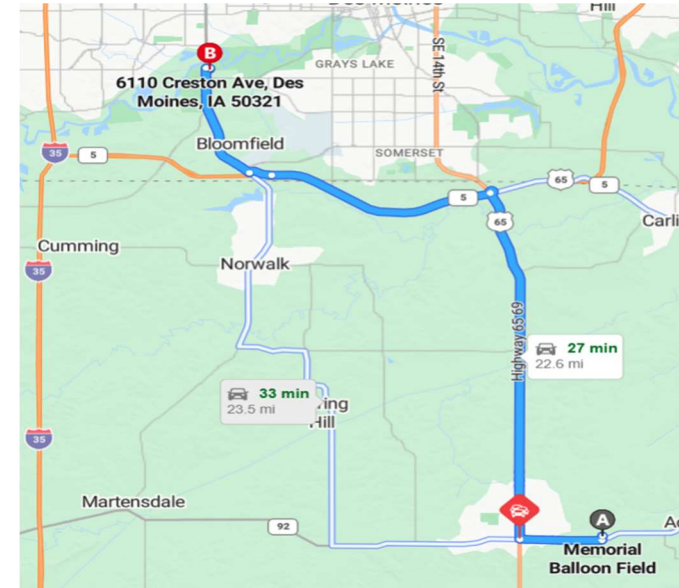

### DIRECTIONS TO THE FIELD

The Des Moines International Airport is roughly 30 minutes from the field.

**From the north via I35 South:** Take exit 151A; right on ramp for I-35 Bus Loop/I-35 S. Exit ramp on right for I-80 E towards Davenport. Take exit 141; right on ramp for US 65 S toward Altoona/Des Moines. Take exit 70A; head right on ramp for US 65 S/US 69 S toward Indianola. Turn Left on to IA 92/E 2<sup>nd</sup> Ave. Field will be on your left.

**From the south via I35 North:** Take exit 36; head on ramp right and follow signs for County Hwy R35. Turn right onto IA 152/Hwy 152. Turn left onto US 69 N/N Main St. Turn right onto IA 92/E 2<sup>nd</sup> Ave. Field will be on your left.

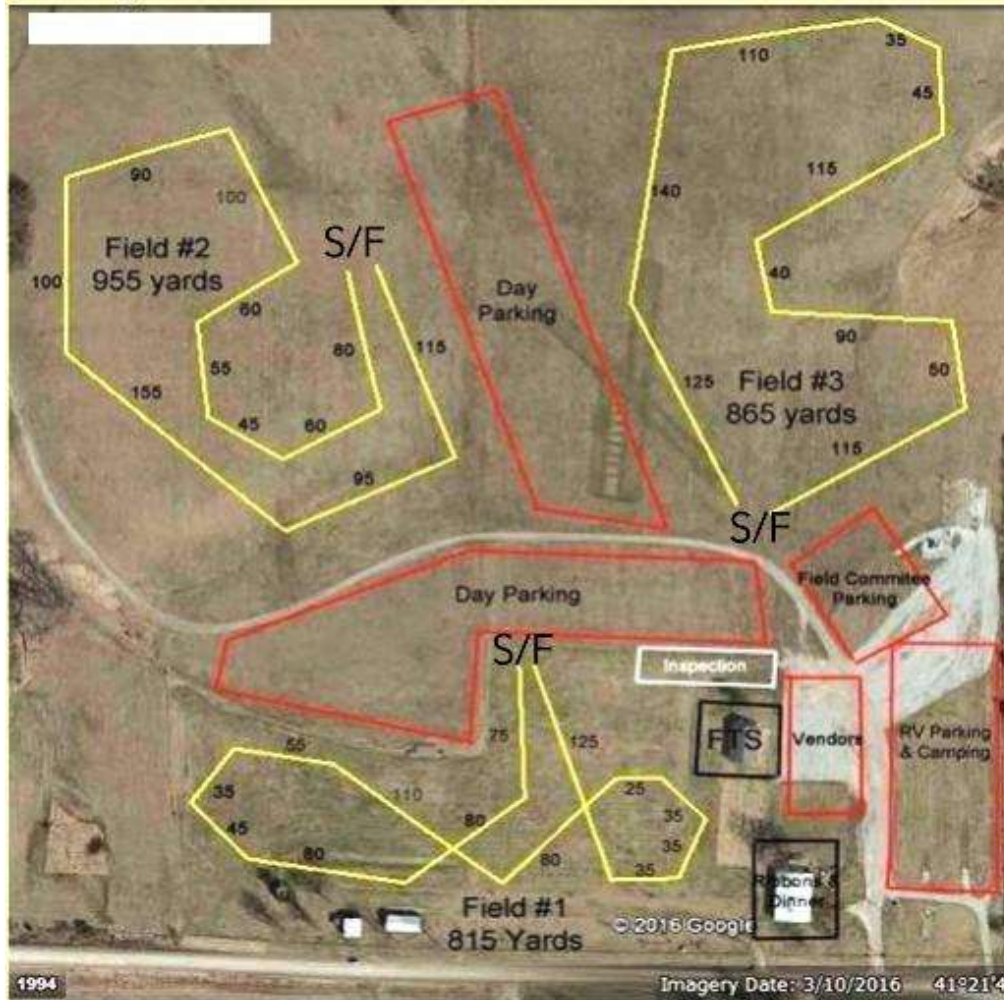

**Courses and Field Layout**

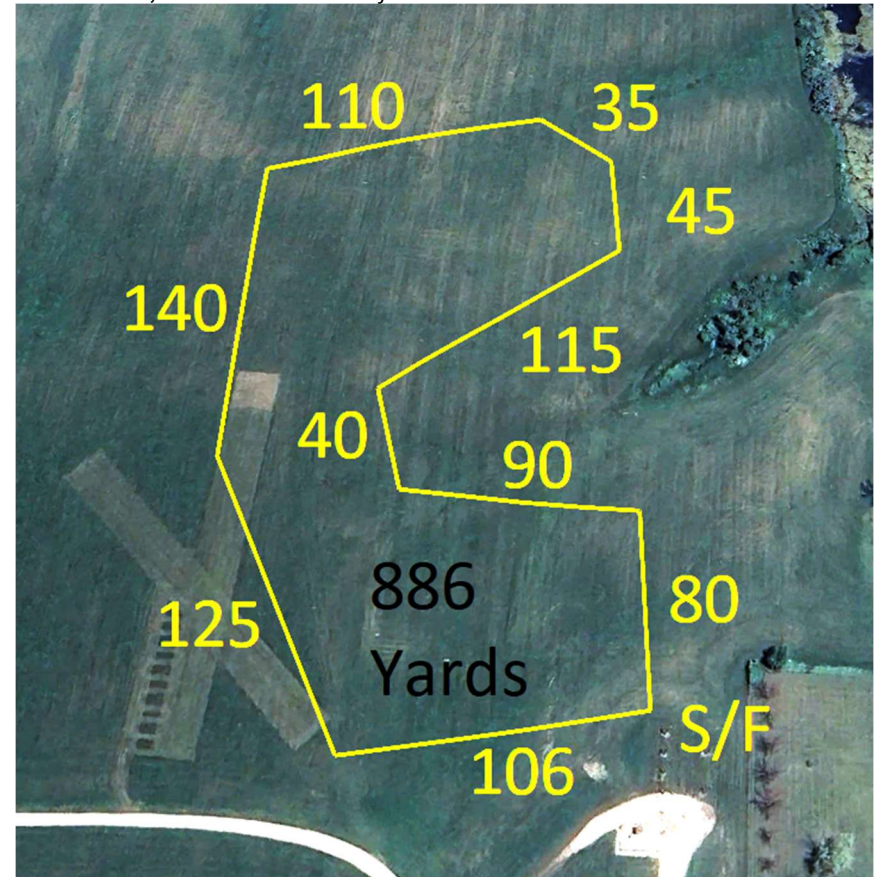
Courses and Field Layout are all shown facing North. The fields are all reclaimed, rolling farmland with elevation changes. Courses will be reversed for finals.

**FIELD 1: 815 yards FIELD 2: 955 yards FIELD 3: 865 yards**

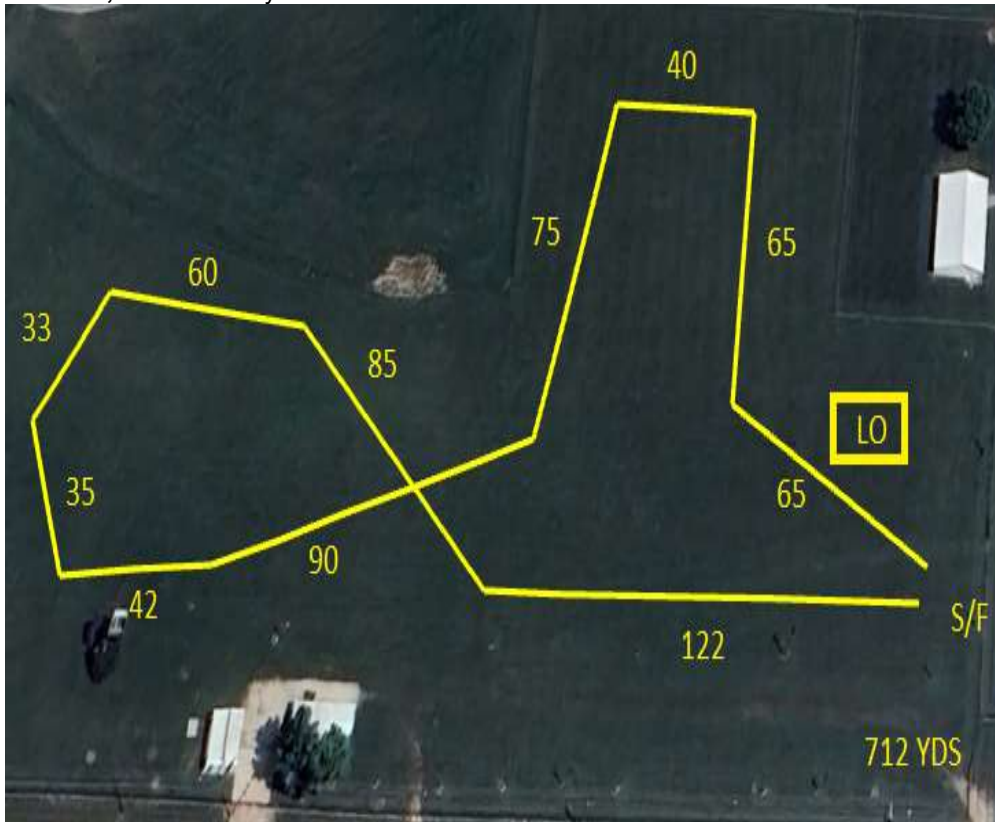


**SATURDAY, Gillette Stake: 886 yards**
