**TIMES AND ELIGIBILITY**

**TRIAL HOURS:** 7:30am until completion  
**ROLL CALL:** 9am am for Trial – *All exhibitors must be present for Roll Call*  
**INSPECTION:** Immediately follows Roll Call with early Inspection available  
**DRAW:** Immediately follows Inspection

**ELIGIBLE BREEDS AND REGISTRY:** Only purebred Silken Windhounds may enter. All entries shall be individually registered with the Silken Registry (ISWS), UKC, an ASFA-recognized foreign or ASFA Board approved registry. A photocopy of acceptable registry must be submitted with each hound’s first ASFA field trial entry.

**Substitutions of hounds will be permitted up to time of roll call each day.**

**LURE COURSING TRIAL**

**OPEN STAKE:** Open to any eligible Silken Windhound excluding ASFA Field Champions of record, that have met certification requirements.

**FIELD CHAMPION STAKE:** Open to Silken Windhound ASFA Field Champions.

**VETERAN STAKE:** Open to any eligible Silken Windhound whose age is over 6 years, on the day of the trial. Points and placements go towards the V-FCh and V-LCM titles. S

**SINGLES STAKE:** Open to any eligible sighthound breed including those disqualified to run in other stakes. They are not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles Stake. Provisional breeds are not eligible for these titles. Hounds will run alone.

**LURE CHASING INSTINCT STAKES:** Open to all Non-Sighthounds and Sighthound mixes: **Small Open** for dogs 17 ½ inches or less at the withers and/or brachycephalic (“flat-faced”) dogs who have not achieved the title of LCC. **Small Excellent:** for dogs 17 ½ inches or less at the withers or brachycephalic (“flat-faced”) dogs who have achieved the title of LCC. **Small Veteran:** for dogs 17 ½ inches or less at the withers and/or brachycephalic dogs over the age of 7 years. **Large Open** for dogs over 17 ½ inches at the withers who have not achieved the title of LCC. **Large Excellent:** is for dogs over 17 ½ inches at the withers who have achieved the title of LCC. **Large Veteran:** for dogs over 17 ½ inches at the withers who are over the age of 7 years. **Sighthound mix Open** for dogs with a sighthound breed in its background who have not achieved the title of LCC. **Sighthound mix Excellent** for dogs with sighthound breed in its background who have achieved the title of LCC. **Sighthound mix Veteran** for dogs with sighthound breed in its background over the age of 7 years. When running as a stake within a regular ASFA trial, small will run 50% of the ASFA course as laid out for the sighthounds up to a maximum of 400 yards. All other stakes will run the full ASFA laid out course length.

**Kennel, Breeder and Bench Stakes will be offered on Nov. 30 & Dec. 1, Saturday and Sunday**

**Kennel Stake:** Two Silken Windhounds, designated at time of entry, owned and kenneled by the same person. Hounds must be entered in one of the regular stakes.

**Breeder Stake:** Two Silken Windhounds, designated at time of entry, bred by the same individual. Hounds must be entered in one of the regular stakes.

**Conformation (Bench) Stake:** An individual hound, in one of the regular stakes, with proof on file with the ISWS of an ISWS conformation championship (certificate copy or email notification - enter 'ISWS Conformation Stake' entry form) or a UKC Grand Championship (certificate copy or UKC Points Check – enter 'UKC Grand Champion' stake entry form). Proof must accompany the entry form.

### EARLY ENTRY FEES AND PAYMENTS

MAIL ENTRIES to the Field Secretary's address above and make checks payable to "CCA". FAX ENTRIES will not be accepted. E-MAIL ENTRIES (to [jennifergysler@gmail.com](mailto:jennifergysler@gmail.com)) will be accepted provided the Field Secretary receives payment before 8:00 pm on Thursday, Nov. 28th, and the entry form is signed. If paying by PayPal, send payment to [socalcoursing@gmail.com](mailto:socalcoursing@gmail.com) only, and add \$2 per entry to cover Pay Pal **transaction fees**. Do not defer the Pay Pal fees to the club or your entry will be declined. **Entries will be acknowledged by email.**

### ENTRY INFORMATION

1. All entries must be one year or older on the day of the trial.
2. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
3. Bitches in season, lame hounds and hounds with breed disqualifications will be excused at rollcall.
4. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered.
5. Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
6. Hounds not present at the time of roll call will be scratched.
7. All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.
8. Hound certification runs will be offered a half hour prior to rollcall.

### OPERATIONAL INFORMATION

1. Each course will be reversed for the final runs and reversed again for the Best of Breed run.
2. Gasoline powered continuous loop lure machines will be used. The lures will consist of plastic strips. Backup equipment will be available.

### GENERAL INFORMATION

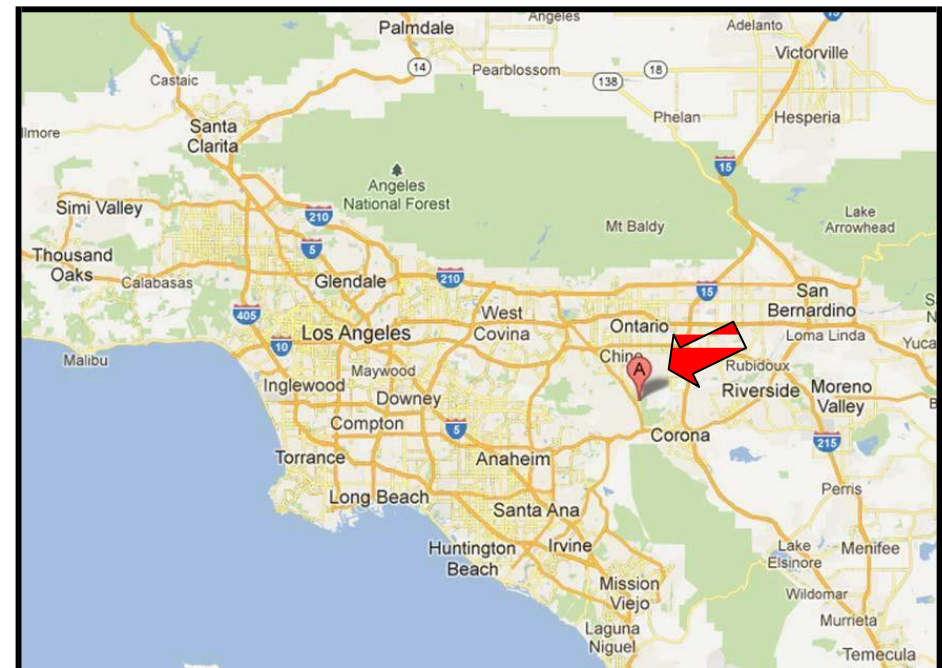
1. Please bring your own food, shade and water.
2. A restroom will be available.
3. No one, except Field Committee members, will be allowed on the field without the expressed permission of the Field Committee.
4. A \$5 fine will be assessed for loose hounds during courses in progress.
5. Anyone failing to clean up their dogs' waste will be excused from the field for the day.
6. Anyone exhibiting unsportsmanlike conduct will be excused from the field for the day.
7. CCA assumes no liability for injury to any person or dog before, during or after the Trial.

### DIRECTIONS

**From Orange County:** Take the 55 North to the 91 East. Next, merge onto the 71 North. Then, take the Butterfield Ranch Road/Euclid Avenue (CA-83) exit. Turn right and the facility will be located on the right side 1/10 of a mile down Euclid Avenue.

**From the Inland Empire:** Take the 91 West onto the 71 North. Exit Butterfield Ranch Road/Euclid Avenue (CA-83) and make a right. The facility will be located on the right side 1/10 of a mile down Euclid Avenue.

**From San Gabriel Valley:** Take the 210 East to the 57 South. Then, transition on the 71 South towards Corona. Take the Butterfield Ranch Road/Euclid Avenue (CA-83) exit and turn left. The facility will be located on the right side 1/3 of a mile down Euclid Avenue.

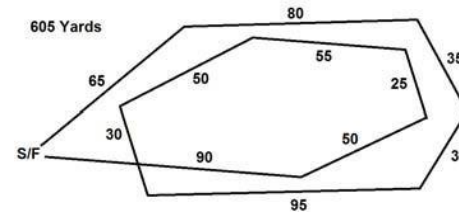

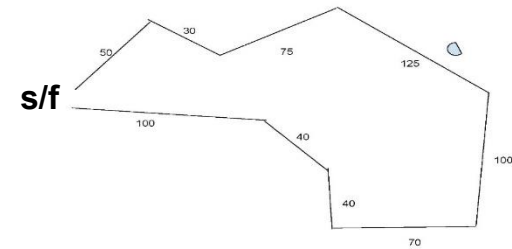

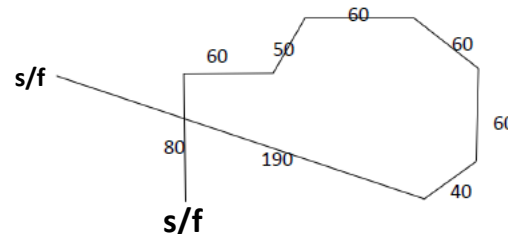
