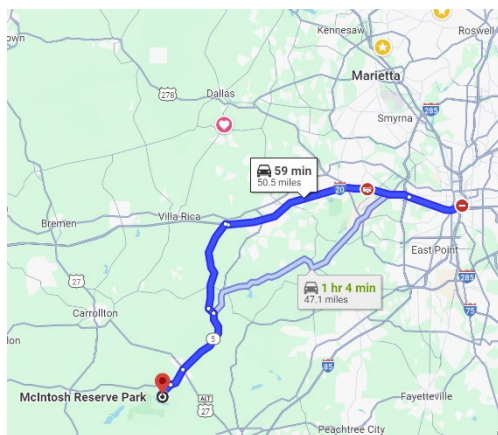

ELIGIBLE BREEDS & REGISTRY

Eligibility. Any hound that is ASFA pointed, or is pointed in its country of residence, or is AKC pointed, is eligible to enter a Regional Invitational in an appropriate stake, including Singles Stake, if offered. Proof of non-ASFA points for hounds should be in the form of a photocopy of the certificate, or a page of formal printing, included with the entry. For a Provisional breed to be eligible, the hound must have received a placement with competition. All points or placements must be earned by the closing date of the event. An eligible hound may be entered in any number of Regional Invitationals. Hounds entered in the Singles Stake are not eligible to be entered in Breeder, Kennel, or Bench stakes.

All Hounds entering Open, Veteran or Provisional Stakes for the first time MUST include a completed ASFA Certification Form or Waiver Form and a copy of the hound's registration certificate (registration requirement waived for NGA Greyhounds; certification waived for Singles Stake entries only).

REGULAR STAKES OFFERED

OPEN STAKE: Any eligible sighthound, excluding ASFA Field Champions of record that has met the certification requirements.

FIELD CHAMPION STAKE: Any ASFA Field Champion

VETERAN STAKE: Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Ibizan Hounds, Rhodesian

Ridgebacks, Salukis and Whippets whose age shall be at least seven years, record that has obtained met the certification requirements.

PROVISIONAL STAKE: Any eligible sighthound of a Provisional breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

SINGLES STAKE: Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field.

LURE CHASING INSTINCT (LCI) STAKE

Open to NON sighthounds and sighthound mixes that have earned 1 lifetime ASFA points. All entries shall be individually registered with the AKC (including ILP & PAL) or the UKC or ASFA number.

Small Open: for dogs 17-1/2 inches or less at the withers and / or brachycephalic ("flat-faced") dogs who have not achieved the title of LCC.

Small Excellent: for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs who have achieved the title of LCC.

Small Veteran: for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs over the age of 7 years.

Large Open: for dogs over 17-1/2 inches at the withers who have not achieved the title of LCC.

Large Excellent: is for dogs over 17-1/2 inches at the withers who have achieved the title of LCC.

Large Veteran: for dogs over 17-1/2 inches at the withers who are over the age of 7 years.

Sighthound Mix Open: for dogs with a sighthound breed in its background who have not achieved the title of LCLCC.

Sighthound Mix Excellent: for dogs with sighthound breed in its background who have achieved the title of LCC.

Sighthound Mix Veteran: for dogs over the age of 7 years with sighthound breed in its background.

All entries must be one year of age or older on the day of the Trial. **LCI is offered on Saturday & Sunday, limit of 10 entries per day.**

CONDITIONS OF ENTRY

All entries must be one year or older on the day of the trial • Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more • Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call • Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered • Hounds with breed disqualifications are not eligible to enter except in the Singles Stake • Hounds not present at the time of roll call will be scratched • All hounds will run twice, in trios if possible or braces (except in the Singles Stake), unless excused, dismissed or disqualified. • Battery-powered continuous loop lure machines will be used, with backup equipment on site • The lure will consist of white plastic strips and/or fur strips • A \$5.00 fine will be collected from the handler of any non-competing hound running loose on the field during the course in progress, and from any person not cleaning up after his/her hound. • Any person, upon reasonable complaint, be asked to leave the grounds of the field trial by the Field Committee and may be disciplined by the ASFA. • Children must be under control of their parent (s) or guardian(s) at all times.

ELIGIBLE BREEDS AND REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Peruvian Inca Orchid, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis and Whippets may be entered in the regular stakes. Provisional breeds currently include purebred Chart Polski, Galgo Espanol, Magyar Agar, Portuguese Podengo (Pequeno), Portuguese Podengo (Media & Grande), and must be individually registered with the appropriate registry. Breed disqualifications apply.

All entries shall be individually registered with the AKC (ILP/PAL included) the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

CERTIFICATION/WAIVER REQUIREMENTS

All hounds must be certified prior to competing in an ASFA trial, except for the Singles Stakes. As time permits, hound certification runs will be offered Saturday afternoon. Certification runs will be \$10.00; forms must be complete. If this is the first trial for your hound, your certification/waiver form and a copy of the hound's registration certificate **MUST** accompany your entry.

NON-REGULAR STAKES OFFERED (Saturday, October 3rd - Regional Invitational)

KENNELSTAKE: For hounds of any individual breeds; an entry shall consist of two hounds, designated at time of entry, in one of the regular stakes being owned and kenneled by the same person. •

BREEDER STAKE: For hounds of any individual breeds; an entry shall consist of two hounds, designated at time of entry, bred by the same individual.

BENCHSTAKE: For any eligible sighthound with proof on file with the ASFA of a conformation championship title from the AKC, CKC or both, or a conformation grand championship title from the UKC.

Park Rules and Regulations

PARK STAFF RESERVES THE RIGHT TO ASK ANYONE TO LEAVE THE PARK AT ANY TIME FOR ANY REASON. NO REFUND WILL BE GIVEN.

- **Pets:** Pets are welcome at Carroll County Parks if leashed (no longer than six feet) and accompanied by the owner at all times. No dog runners allowed. No tying pets to trees. Owners should clean up after pets.
- **Intoxicants:** Consumption or use of alcoholic beverages or intoxicants is unlawful in any public-use area.
- **Campfires:** All campfires must be kept in designated areas such as a fire ring. Never leave a campfire unattended. Smaller fires with coals (rather than large flames) are better for campfire cooking and toasting marshmallows.
- **Collecting:** All wildlife, plant life, driftwood, artifacts and any other natural or man-made features are protected and may not be disturbed or removed. Please leave wildflowers for other visitors to enjoy. Possession of metal detecting equipment is prohibited. No hammocks, dog runners, etc. to be anchored to trees.
- **Motor Vehicles:** Park roads are public roads. All vehicles are subject to license safety requirements and regulations of the Georgia Department of Public Safety. ATVs and golf carts are not allowed.
- **Noise Levels:** Please be considerate of guests who are visiting the park for a quiet, natural experience. Radios, televisions, musical instruments and all other noise-making devices are not to be used between 10 p.m. and 7 a.m. and must be kept at low volumes during other times. NO PA SYSTEMS, NO DJs, & NO LIVE BANDS ALLOWED. Noise levels must be contained to the area that you have reserved ONLY. If any complaints of noise levels are made, you will be asked to turn music OFF completely. Failure to do so will result in you forfeiting your reserved area, and you will be asked to leave premises. Music content MUST remain family friendly without vulgar language or explicit content. NO REFUNDS.
- **Visitors:** Visitors are welcome; visitors must leave prior to closing times.
- **Weapons:** Bows and arrows, explosives, fireworks, slingshots, fishing spears or any device that discharges projectiles by any means is prohibited. Firearms must be unloaded, cased and stored, unless a person possesses a valid weapons-carry license for a firearm that is valid in Georgia.

- The field is a flat, groomed 12-acre "event" field in McIntosh Reserve Park.
- The field has some natural shade near the Chattahoochee River.
- Please bring your own shade and water.
- The course direction will be in reverse for all final runs.
- The LEGS Coursing Club reserves the right to alter the course diagram as required by weather and/or field conditions on the day of the trial.

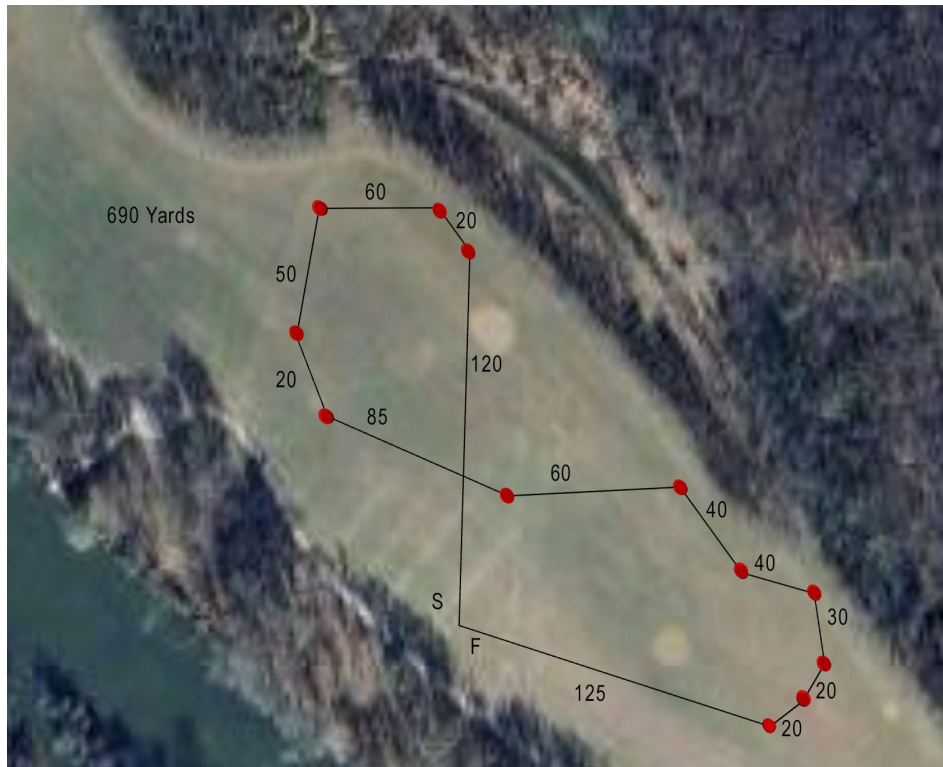
