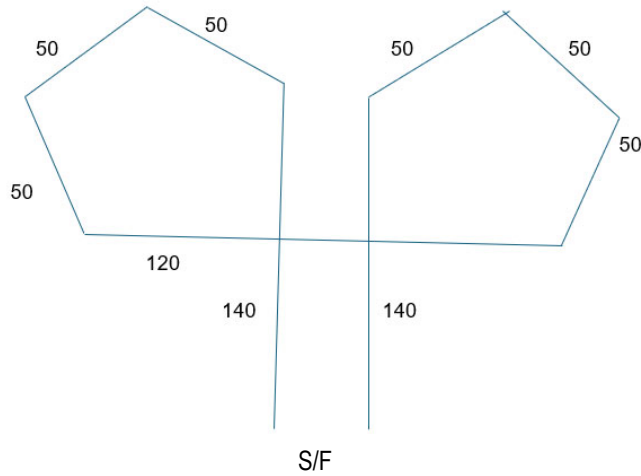

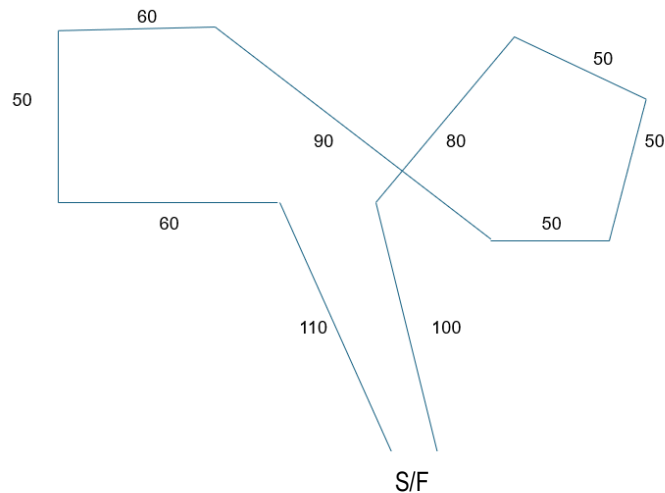
SATURDAY

Entries will NOT be acknowledged by return mail. Substitutes for lame or in-season hounds will be allowed if substitute has the same owner and the trial secretary is notified before the close of day-of-trial entries. Refunds will NOT be granted for any other reasons. There will be a \$30 fee for any NSF checks.

Awards: Ribbons-1st blue; 2nd-red; 3rd-yellow; 4th-white; NBQ - Green, Singles Winner- Blue/Gold, Best of Breed - purple & gold rosette. BIF – Red, White & Blue Rosette

Please do not bring bitches in-season to these trials; just report the bitch in-season to the trial secretary.

All Hounds entering Open, Veteran or Provisional Stakes for the first time MUST include a completed ASFA Certification Form or Waiver Form (with proof of title) and a copy of the hound's registration certificate (registration requirement waived for NGA Greyhounds only, certification waived for Single Stake entries only).

ELIGIBLE BREEDS & REGISTRY Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, and Whippets.

Provisional breeds may be entered in the Provisional Stake or the Singles Stake. Provisional breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

REGULAR STAKES OFFERED

OPEN STAKE: Any eligible sighthound that has met certification requirements, excluding ASFA Field Champions of record.

FIELD CHAMPION STAKE: Any ASFA Field Champion

VETERAN STAKE: Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Ibizan Hounds, Rhodesian Ridgebacks, Salukis and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles. **PROVISIONAL STAKE:** Any eligible sighthound of a Provisional breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

SINGLES STAKE: Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPS titles from the Singles stake. Provisional breeds are not eligible for these titles.

Best In Field will be offered both days.

Conditions of Entry:

All entries must be one year or older on the day of the trial.

Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.

Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call.

Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake.

Hounds not present at the time of roll call will be scratched.

All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.

Practice and hound certifications offered after the completion of the trial on Saturday, time, weather, and equipment permitting.

Food will be provided for judges and workers.

There is very little shade at this field, bring your own water.

CAMPING OPTIONS

Camping is available at the Fair Grounds. There is a \$30.00 fee for hook up camping, \$15.00 for non-hook up camping payable directly to the fair grounds via check or cash that weekend. Reservations are not required, just show up and pick a spot.

There are 8 – 12 RV hook ups next to the field, however the club will be using the ones nearest to the field to power our equipment and for judges. There are many more spots a slight distance from the field.
