Eligible Sighthound Breeds & Registry

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etnas, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Peruvian Inca Orchids, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, Whippets, and Provisional breeds may be entered. Current Provisional breeds include purebred Chart Polski, Galgo Español, Magyar Agar, Portuguese Podengo, and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

Owner/handlers under the age of eighteen years must be signed/co-signed by a parent or guardian. ***Substitutes for lame or in-season hounds are allowed if the substitute has the same owner and the Field Secretary is notified at least 30 minutes prior to roll call.***

Stakes Offered

OPEN- Any eligible sighthound that has met certification requirements, excluding ASFA Field Champions of record.

FIELD CHAMPION - Any ASFA Field Champion.

VETERAN - Any eligible sighthound that has met certification requirements whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years and Ibizans, Afghans, Rhodesian Ridgebacks, Salukis, and Whippets, whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.

PROVISIONAL - Any eligible sighthound of a provisional breed that has met certification requirements. Not eligible for Best of Breed or Best in Field.

SINGLES - Any eligible sighthound including those disqualified to run in other stakes. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Provisional breeds are not eligible for these titles.

In conjunction with SLASH's trials on October 17-18, 2026, the ASA (American Saluki Association) will be offering the North Central Regional trophy for Salukis only.

To claim the trophy, the winning Saluki must be owned by an ASA member.

Lure Chasing Instinct (LCI) Stakes Offered

LCI is offered both days. Open to NON sighthounds and sighthound mixes. All entries shall be individually registered with the AKC (including ILP & PAL) or the UKC. A photocopy of an acceptable registry must be submitted with each dog's first ASFA field trial entry. Dogs without a recognized registry number may obtain an ASFA ID number for a \$10 registration fee at time of entry.

SMALL OPEN - for dogs 17-1/2 inches or less at the withers and / or brachycephalic ("flat-faced") dogs who have not achieved the title of LCC.

SMALL EXCELLENT - for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs who have achieved the title of LCC.

SMALL VETERAN - for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs over the age of 7 years.

LARGE OPEN - for dogs over 17-1/2 inches at the withers who have not achieved the title of LCC.

LARGE EXCELLENT - for dogs over 17-1/2 inches at the withers who have

LARGE VETERAN - for dogs over 17-1/2 inches at the withers who are over the age of 7 years.

SIGHTHOUND MIX OPEN - for dogs with a sighthound breed in its background who have not achieved the title of LCC.

SIGHTHOUND MIX EXCELLENT - for dogs with sighthound breed in its background who have achieved the title of LCC.

SIGHTHOUND MIX VETERAN - for dogs with sighthound breed in its background over the age of 7 years.

When running as a stake within a regular ASFA trial, Small will run 50% of the ASFA course as laid out for the sighthounds up to a maximum of 400 yards. All other stakes will run the full ASFA laid out course length.

Hound Certification Runs and Practice

Certification: Any entry marked *First Time Entered*, other than those entered in the Singles Stake, must present a completed signed ASFA hound certification form or an AKC QC certificate to the Field Trial Secretary BEFORE entries close. A photocopy of an acceptable registry must be submitted with a hound's first ASFA field trial entry. This requirement is waived for hounds registered with the National Greyhound Association.

Certification runs will be offered at the cost of \$5.00 per run on Saturday **only** after the completion of the Saturday trial. It is the responsibility of the entrant to find another hound of the same breed or similar running style to run with his/her hound for the certification. A sign-up sheet will be available on the day of the trial.

Current SLASH members may certify their hounds at no cost.

Practice: Practice will be scheduled after the certifications, on Saturday **only** time, equipment, and weather permitting.

Practice runs are \$5.00. Current SLASH members may practice their hounds at no cost. A sign-up sheet will be available on the day of the trial.

Food

There will be **NO** food offered for lunch on Saturday nor Sunday. Bring your own snacks and beverages. There are **NO** nearby restaurants, so please plan accordingly.

There IS a Saturday late afternoon / after trial feast at no charge - see elsewhere in premium for information!

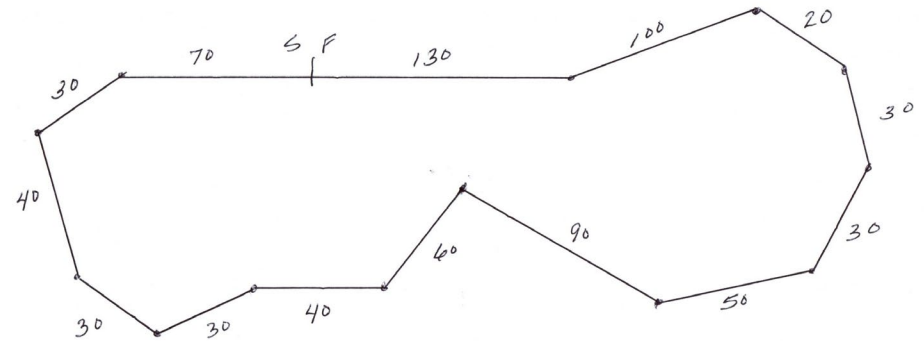

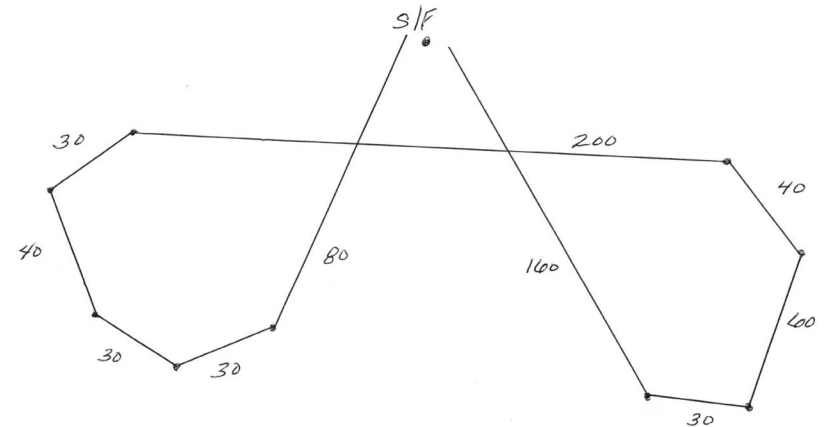

The course will be reversed for the finals, runoffs and Best of Breed.

The Members of SLASH reserve the right to alter the course plans as required by weather, terrain and/or field conditions on the date of the trial.

There will be a \$5.00 fine assessed for any loose hound not participating in the course.

The field IS fully fenced with gently rolling ground.



Other Information

- All entries must be one year of age or over on the day of the trial.
- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- Bitches in season, hounds with breed disqualifications, and lame hounds will be excused.
- Hounds not present at roll call will be marked absent and are not eligible for refund of entry fee.
- Monorchid, cryptorchid, spayed, or neutered hounds may be entered.
- All hounds will run twice, in trios if possible or braces (except in the Singles Stake), unless excused, dismissed or disqualified.
- Muzzles are not required; it is the responsibility of the owner to determine if their hound needs to be muzzled.
- Hounds with breed disqualifications are not eligible to enter except in the Singles Stake.
- Lure machine is battery powered, continuous loop. Back-up equipment is available.
- Lure will consist of highly visible plastic strips.
- A fee of \$40 will be assessed for any returned checks.
- There will be a \$5 fine for any loose hounds on the field that is not part of the course in progress.
- There will be a \$15 fine for any owner/handler who does not clean up after their hound.
- Substitutions for hounds already entered are allowed up 30 minutes prior to roll call on day of trial.
- Hound certification runs will be offered Saturday only following trial, pending condition of the equipment and weather.
- Persons exhibiting conduct detrimental to ASFA/SLASH/any hound(s) /other person(s) will be asked to leave the trial site.

Food

There will be **NO** food offered for lunch on either Saturday or Sunday. Bring your own snacks and beverages. There are **NO** nearby restaurants, so please plan accordingly. ***See separate page for information on Saturday after trial meal being provided at no charge.***

Event Parking

Parking will be along two sides of the field, NO shade. Water will be available at a distance, bring your own shade and water for your hounds.

Site Information

The field IS fully fenced with gently rolling ground. No running water available, there is a pond for cooling off dogs, there is no shade. Bring your own water and shade for your hounds. Porta-John on site.

Keep dogs on lead even before/after trial as there are goats, cows and dogs in fenced paddocks on the property. Please be respectful of the animals and do not let your dogs antagonize them.

Note: the animals ARE at a distance from the coursing field and do not cause a distraction for dogs coursing.

Turn East and go approx. 2 miles to Jefferson Street, it is the first street in the village of Kell. Turn South and go approx. 1 mile to stop sign. Continue STRAIGHT thru stop sign for approx. 1/2 mile to first set of double chain link gates on East.
