Eligible Breeds:

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhound, Sloughis, Whippets, and Provisional breeds may be entered in the regular stakes. Current Provisional breeds include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

Stakes Offered:

Open Stake – Open to hounds who have met certification requirements. Excluded ASFA Field Champions of record.

Field Champion Stake – Any ASFA Field Champion of record.

Veteran Stake – Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks, Salukis, Ibizan Hounds and Whippets whose age shall be at least seven years that have met certification requirements. Points go toward V-FCh or V-LCM. **Singles Stake –** Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPS titles from the Singles stake. Provisional breeds are not eligible for these titles.

Provisional Stake – Any eligible sighthound of a Provisional breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field. **Best In Field** – Will be offered on Saturday.

WINDWALKER PERPETUAL TROPHY – All hounds belonging to club members paid by January 31, 2024 are eligible to compete for this trophy. The hound from each breed with the highest cumulative score over the 2 days will be eligible to run off for the trophy.

Any exhibitor or participant who shows any sign of illness prior to or during the event will be asked to leave the trial site, and their entry fees will be refunded in full. Any exhibitor or participant unable or unwilling to adhere to the safety guidelines will be asked to leave the trial site.

Conditions of Entry:

Hounds must be one year or older on the day of the trial. All hounds will run twice, in trios if possible or braces unless excused, dismissed or disqualified. Bitches in season and lame hounds will be excused. Hounds not present at the time of roll call will be scratched after a five-minute grace period. Each entry will be examined at inspection for breed disqualifications. Hounds determined to have a breed disqualification at the time of roll call shall be barred from competition and their entry fees shall be refunded. Spayed, monorchid, cryptorchid, and neutered hounds without breed disqualifications may be entered. Regular stakes will be split if 20 or more entries are present in any one stake at the time of the draw. Any hound that displays aggressive behavior during trial hours will be excused for the day. A penalty of \$5 will be assessed for any loose hound not competing in the course in progress.




Directions to 2100 West 11400 South, South Jordan, UT:
