DIRECTIONS TO THE FIELD

The Kominek Farm - Field Entrance 99
Glendale Rd., Limestone TN 37681

Directions— Expect 20-30 minute travel time from most hotels. Google Maps works well. Verizon has the best cell coverage, but reception on the field may be spotty.

From I-81 (N, E, W) (12 mins): NEVER USE EXIT 44. Take exit 50 for TN-93 south for 1.8 miles. Continue straight onto TN-81 for 2.2 miles. Right on Cherry Hill Rd for .6 miles. Bear left to Martin Rd. for .9 miles. Right on Glendale for 2.7 miles. From I-26 (S) (40 mins): Take exit 37 north on TN-107/TN-81 for about 22 miles. Follow signs for TN-81N through Jonesborough. After passing the Marathon, keep an eye out for a sharp right turn, where you'll turn left onto Pleasant Grove Rd. for .8 miles. Turn right onto Glendale Rd for 3.4 miles.

***NEW* RV NOTICE!:** Highly advised that if you come in via: I-81 -> Hwy 93 (Exit 50) -> Hwy 81N -> Oak Hill Cir (Across from Oak Hill Baptist Church) -> Oak Hill Rd. -> Martin Rd. -> Glendale Rd. Any other way will have turns/roads you will NOT want to take a rig or trailer down.

Eligible Breeds and Registry

Only purebred Whippets may enter this trial. All entries shall be individually registered with the AKC (ILP & PAL included), FCI, UKC or an ASFA recognized foreign or an ASFA approved registry. A photocopy of acceptable registry, hound certification or waiver and proof of title must be submitted with each hound's first ASFA field trial entry.

NO PRACTICES, NO CERTIFICATIONS, AND NO FUN RUNS ARE OFFERED.

Stakes Offered (Regular Stakes)

Open: Any eligible Whippet that has met certification requirements, excluding ASFA Field Champions of record. The hound certification will be waived for a hound that has earned a lure coursing title from another recognized organization, if such title requires competition, and if a waiver for such title has been approved by the ASFA. If first time entered hound—proof of title and waiver form must accompany entry.

Field Champion: Any ASFA Field Champion Whippet

Veteran: Any eligible Whippet that has met certification requirements whose age is at least 7 years.

Singles: Any eligible whippet, including those disqualified to run in other stakes. Singles entries are not eligible for Best of Breed. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Entries in the Singles Stake are **LIMITED TO THE FIRST 15 SINGLES TO ENTER**. No first time entered dogs are allowed to enter the Singles Stake.

Non-Regular Stakes Offered (\$10 each entry)

Kennel: For two Whippets, designated at the time of entry, each entered in one of the regular stakes, owned and kenneled by the same person.

Breeder: For two Whippets, designated at the time of entry, each entered in one of the regular stakes, bred by the same person.

ASFA Operational Policy:

O-TRIALS41--An owner may have more than one entry in a Kennel or Breeder Stake as long as the two hounds comprising each entry are properly identified at the time of the entry. A hound may be part of only one Kennel and one Breeder entry.

Generation: Each entry in this stake shall consist of a stud dog OR a brood bitch and one dog produced by that dog. Both dogs must be entered in a regular stake but need not be owned or bred by the same person. Each Stud Dog or Brood Bitch can only be paired with one chosen offspring; however, an offspring can be paired with either one or both parents.

Bench: an entry shall consist of a single whippet with proof on file with the ASFA of a conformation champion title from the AKC, CKC or both or a conformation grand champion title from the UKC. (Proof of championship must accompany entry. A printed copy of the certificate is acceptable.) (There is no charge for this entry but appropriate box must be checked on entry form)

Dual Champion: For ASFA FCh Whippets that have been awarded the AKC Bench Championship by the closing date of entries. The championship status of the winner must be verifiable. (There is no charge for this entry but appropriate box must be checked on entry form)

RIBBONS

Rosettes will be offered for placements in each Stake: 1st Blue, 2nd Red, 3rd Yellow, 4th White, NBQ Green, and High Scoring Singles—Navy/Gold

Deluxe Rosettes will be offered for: Best of Breed—Purple & Gold; Open Stake Winner, FCh Stake Winner, Veteran Stake Winner; Kennel Stake Winner, Breeder Stake Winner, Bench Stake, Dual Champion, and Generation Stake winner.

TROPHIES

Trophies on Saturday will be pottery by Charlie Tefft Pottery.

Other prizes may be offered by the American Whippet Club.

****In Bench and Dual Ch stakes there will be only one winner with no championship points awarded. All other Additional Stakes, awards will be given for 1st - 4th. Use a separate form for each entry in each of the above stakes!**

CONDITIONS OF ENTRY

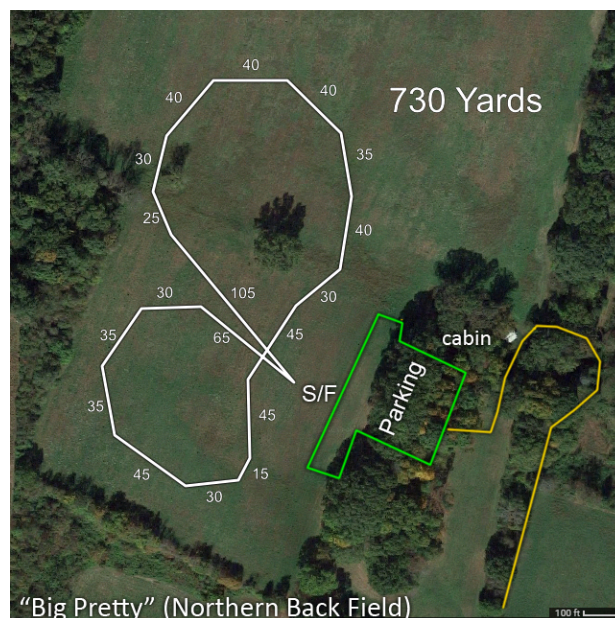
- All Whippets must be one year or older on the day of the trial. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- All attempts will be made to separate hounds that have the same owner and live in the same household – these entries must be submitted together to qualify.
- Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call (unless entered in the Singles Stake) and entry fee refunded.
- Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered.
- Whippets with breed disqualifications are not eligible to enter.
- Whippets not present at the time of roll call will be scratched. No refund will be issued.
- All Whippets will run twice, in trios if possible or braces, unless excused, dismissed, or disqualified.
- Battery or gas powered, continuous loop lure machines will be used. The lure will consist of black or white plastic strips and/or skins. Back up equipment will be available.
- The members of the field committee reserve the right to alter the course plan as required by weather and/or field conditions on the day of the trial.
- There will be a \$5 fine assessed for any loose hound not taking part in a course in progress.
- Persons exhibiting conduct detrimental to ASFA/AWC/any hound(s)/ other person(s) will be asked to leave the trial site.

CERTIFICATION REQUIREMENTS

All Whippets must be certified **prior to closing date of entries** in an ASFA trial. If this is the **first trial** for your Whippet, the judge-signed **certification form or waiver (with proof of title)** as well as a **copy of the registration** certificate **MUST** accompany your entry or it will be considered conditional and not accepted.

COURSE PLAN

The course is 730 yards and will be reversed for finals and again for run-offs.



FACILITIES

1. Port-a-potties will be available near the fields.
2. There is minimal shade in the parking areas, please bring your own. The field has little shade and has natural and fence boundaries, the entrance will be unobstructed.
3. Running water is NOT available on the field.
4. Both RV and tent camping is permitted.
5. Please make sure to enter at the "FIELD ENTRANCE/GATE 1" and not the driveway of Eddie and Selma's home.
6. Neither Kominek Farms nor the AWC and its members will be held responsible for any accidents at this trial.

REFUNDS

Refunds will be given if a **written request is received by the trial secretary on or before the trial closing date.** After the trial closes, a refund will be given for **ill or injured dogs or handlers, bereavement, and/or family emergencies** if the trial secretary is notified **prior to the close of roll call for the trial.**

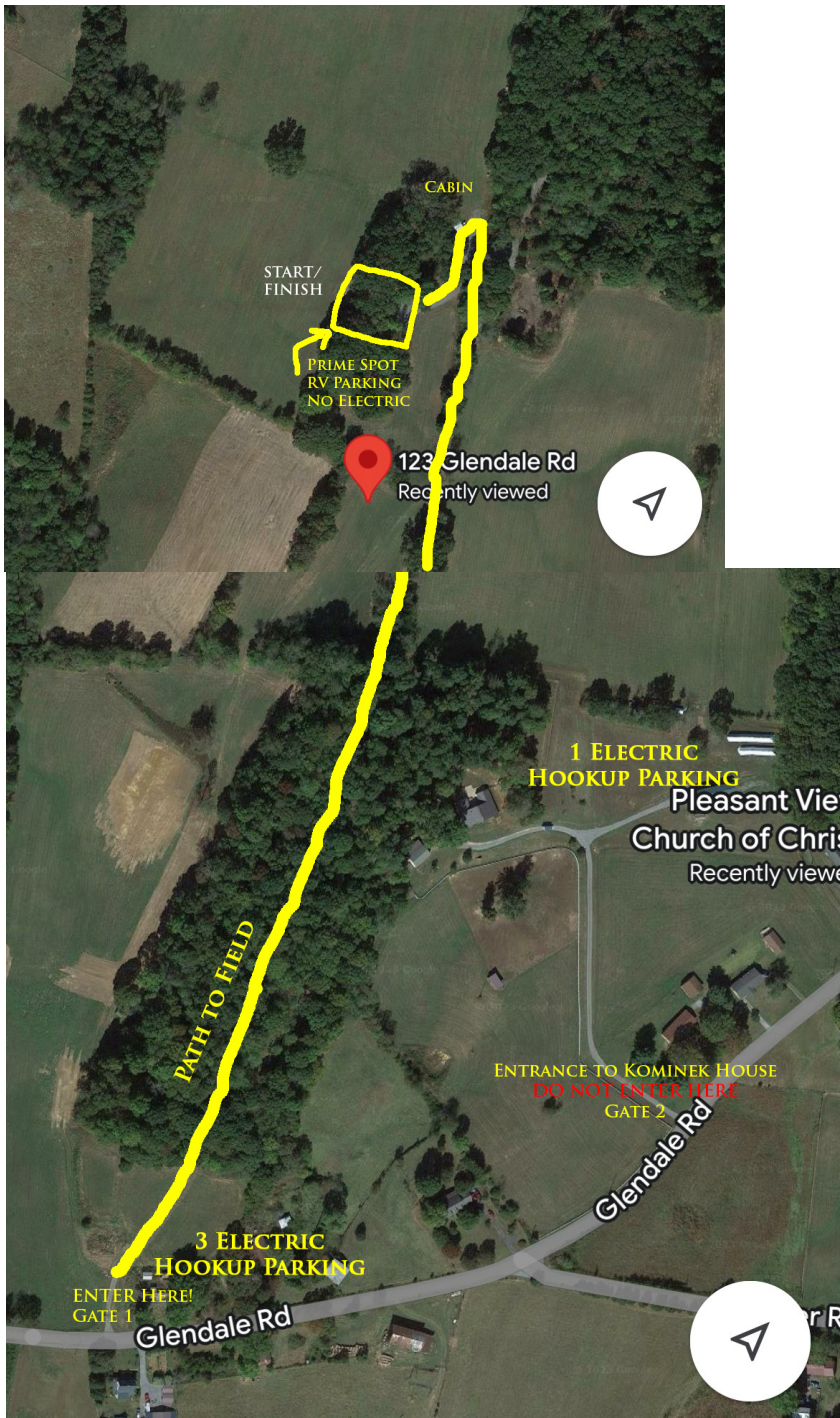

Notes from the Field Trial Secretary:

- **PLEASE SEPARATE YOUR ENTRIES.**
Each ASFA entry must be 8½ by 5 ½ inches in size (as above). To fix the size problem when the form prints out a full page, select 2 pages per page when printing the form, or select booklet if that's an option.
- If your whippet becomes lame or is in season prior to the trial, please let the field trial secretary know ASAP at 2024awcasfafts@gmail.com (PREFERRED) or 517-749-1115.
- If you have questions, please telephone Jessica (517-749-1115) before 9:30 pm EDT or contact by text or e-mail address (2024awcasfafts@gmail.com). Jessica is on Facebook and can be reached through messenger as well.
- If you would like confirmation of your mailed in entry, please include a stamped, self-addressed envelope or postcard. Online entries will receive a confirmation via email if you put an email address on the entry form.
- Please be sure to include your **telephone number** AND **e-mail address** on your entry form in case there are questions about your entry. The information will not be used for any other purpose. Additional trial information may be sent out via email and/or facebook posting after entries close.
- If you are completing your entry form by hand, please write clearly. The information in the catalog is dependent on the legibility of what is written.
- Please include all titles, separated by commas, for entries with multiple titles. All requested copies of titles, certifications, or registration paperwork must accompany the entry and be received by the FTS PRIOR to close of entries.
- Please be sure to notify Jessica before **April 3rd** with regard to bitches in season, lame hounds, etc. if you are substituting a dog. **No refunds will be given for lame or in-season hounds, if Jessica is not notified by the owner prior to the close of roll call for the trial. (Inspection)**
- If you send your entries overnight, please make sure that signature is **NOT** required. You will need to check the box on the address label for “no signature required”.
- Please note: if you are entering any of the Additional Stakes, please include the regular stake (Open, FCh, Vet) in which each dog is entered. This is very helpful when calculating the scores and saves a lot of time.
- If you really want to understand what's going on (and why), please go online and read/download the running rules!
- If ever you think the scores don't reflect what you think your dog earned, please don't hesitate to ask the FTS to see the judges sheets! It could be a data entry error by the FTS or a blanket error by the judge. It could also be the judge had a better view of the course. If you don't ask, you'll never know. But you cannot speak to a judge without permission of the trial chair, and exhibitors are never allowed to go to the judge while he/she is on the field.
- Please read the rulebook. That was important enough to list twice!
